Minutes

The minutes from the regular meeting on March 13, 2025 were reviewed. A motion by Lynette Dye, seconded by Jeannie Malone, to approve the minutes.

Treasurer's Report

Brad Detering outlined the treasurer's report, submitted by John Gaston, which showed a March 31, 2025 balance of \$355,549.96

Debbie Woodruff had made contact with both the Baggett and Maxey families about moving their remaining funds into the general endowment fund since neither family was offering their scholarships any longer.

A motion was made by Jeannie Malone, seconded by Dena Heflin, to move the remaining funds of the Baggett and Maxey Scholarships into the general fund.

Vote: 9 ayes, 0 nay, motion carried.

The profit and loss statement showed a total profit for the year to date is \$17,683.37

A motion was made by James Toth, seconded by Dena Heflin, to receive the treasurer's report.

Vote: 9 ayes, 0 nay, motion carried.

Committee Reports

Publicity-The Elk's chicken dinner is scheduled for August 24, 2025. The directors were reminded to share on their personal Facebook pages. There was a question raised about whether a student group would be able to help on that day. Brad Detering indicated that he had contacted several groups to assist, but did not have confirmation of any one group yet. Debbie Woodruff also explained that she needed to get with Brad Detering for details in order to be able to publicize the science lab renovation and the Tony Harris donation to that goal.

Scholarship-Debby Hays reported that the scholarship committee was meeting after this meeting to select the scholarship recipients.
